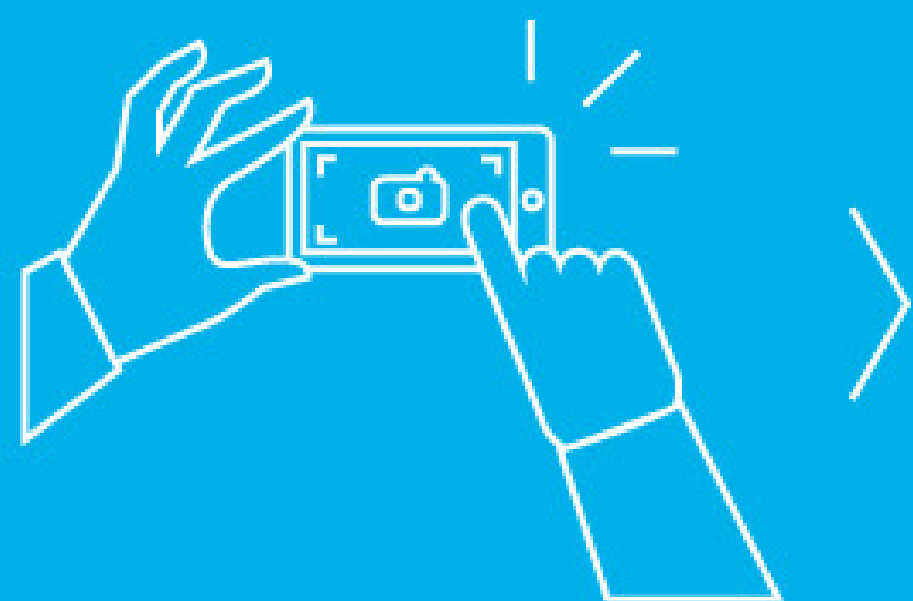

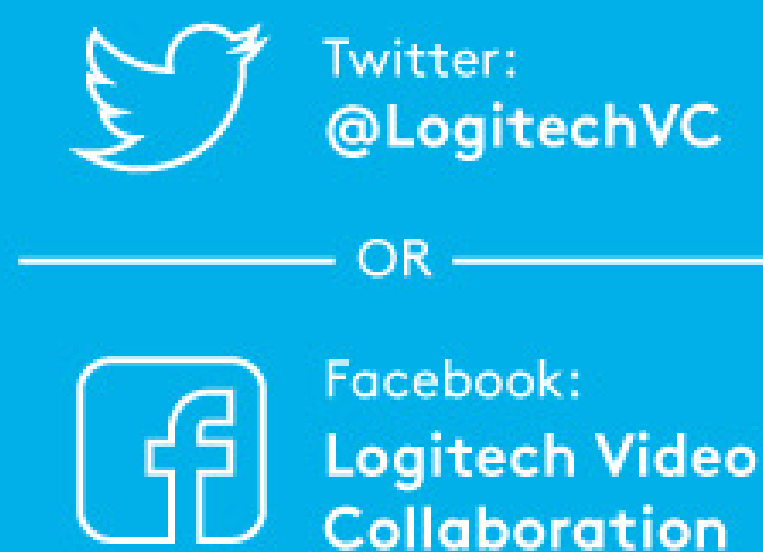

LOGITECH INFOCOMM 2016 PROMOTION OFFICIAL RULES

ELIGIBILITY: The Logitech InfoComm 2016 Promotion (“Promotion”) is open to attendees of InfoComm 2016, held at the Las Vegas Convention Center located in Las Vegas, Nevada, between June 8-10, 2016, who are 18 or older at the time of entry. Void outside the U.S., and wherever else prohibited by law. Employees of Logitech (the “Sponsor”) and its respective subsidiaries, affiliates, advertising and promotion agencies, and the immediate family members of, and/or those living in the same household of each, are not eligible to enter. HOW TO ENTER: NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS PROMOTION AND PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. There are two (2) steps to enter the Promotion.

Photo Upload (Entry Step #1): During the Promotion Period, take photo(s) of any Logitech product present at the InfoComm event outside of the Logitech Booth and upload each to your Twitter or Facebook account with the hashtags #InfoComm16 and tag on Twitter, @LogitechVC or Facebook, tag Logitech Video Collaboration. Once you have uploaded the photo(s), visit the Logitech Booth, located at Booth #N2329.
